Blue call meets all code black criteria:

- · Requires intubation + GCS<8
- Clinical suspicion of significant head injury
- Pupil changes suggesting impending herniation

ACode Black Call can also be activated, at the discretion of the TTL, if a CT head scan reveals acute haematoma with mass effect

Consider whether code red also required

On arrival

On arrival

- Handover
- Primary survey
- Manage airway
- Seek and treat other injuries
- CT head +/- further imaging

IMMEDIATE RESPONSE:

- 1. RECEIVE PATIENT IN RESUS BAY 8
- 2. PREPARE 3ML/KG OF 3% SALINE (OR 5% SALINE) (MAX DOSE 350 MLS AS PER ADULT PROTOCOL)
- 3. IMMEDIATE NEUROSURGICAL ASSESSMENT
- 4. PREPARE FOR TRANSFER & DECISION REGARDING TRANSFER TO THEATRES OR CT
- 5. THEATRE COORDINATORS TO CONFIRM THEATRE LOCATION

Disposition

- 1. THEATRE ALLOCATION TO BE CONVEYED TO ED CONSULTANT/TTL AND TO NEUROSURGEON
- 2. SAFE TRANSFER TO THEATRE USING STOPP TOOL

Please Note

- Time-critical surgery should be carried out at the MTC
- Decisions regarding the <u>ongoing</u> management of the neurosurgical patient post-op rest jointly with the Consultant for Neurosurgery and the Consultant for PCCU
